CREDIT COURSES AND PROVINCIAL EXAMINATIONS JULY 24th - 28th

Provincial examinations will take place between July 24, and July 28, 2023, inclusive. A maximum of two courses may be taken. Courses commence on Monday, July 3, (see calendar on reverse side) and they terminate on the day of examination. Students must attend all classes.

**RÈGLEMENTS CONCERNANTS LES ÉCOLES
PRIVÉES**

- a/ "Ce document ne peut être transporté cédé ou vendu; le paiement de cours non encore suivis ne peut être fait par billet à ordre". (Art. 36 d/ des Règlements)
- b/ "Toute personne qui s'engage à suivre des cours dans une institution peut se libérer de son engagement en donnant avis par lettre recommandée mise à la poste dans le dix jours francs de la date de son engagement, pourvu qu'elle n'ait pas effectivement commencé à suivre ces cours pendant ce délai de dix jours." (Art. 59 de la Loi)
- c/ "Un élève qui n'a suivi qu'une partie d'un cours d'enseignement dans une institution n'est tenu de payer que le prix des leçons effectivement reçues, en proportion de celui qui avait été convenu pour le cours entier. Dans ce cas, l'institution peut exiger une indemnité n'excédant pas un cinquième du prix convenu pour le cours entier, pourvu toutefois que dans aucun cas, le montant global payé n'excède pas le prix total convenu pour ce cours." (Art 61 de la Loi)
- d/ "S'il n'y a eu aucune leçon effectivement reçue, l'institution ne peut exiger qu'une indemnité n'excédant pas un dixième du prix total convenu pour ce cours." (Art. 62 de la Loi)
- e/ Pour assurer la protection de l'élève aux termes des articles 59, 61 et 62 de la Loi et 31 des Règlements reproduits ci-dessous, l'institution s'engage à ne transporter ni céder, ni vendre le présent contrat.

**REGULATIONS CONCERNING
PRIVATE SCHOOLS**

- a/ "This document may not be transferred assigned or sold; payment for courses not yet given may not be made by promissory note." (Section 36 (d) of the Regulations)
- b/ "Any person who binds himself to follow courses in an institution may free himself of his engagement by giving notice by registered letter mailed within ten clear days of the date of his engagement, provided that he has not actually begin to follow such courses within ten days delay. (Section 59 of the Act)
- c/ "Any pupil who has followed only a part of a course of instruction in an institution shall be bound to pay only the price of the lessons actually received in comparison with the price agreed upon for the entire course. In such case, the institution may require an indemnity not exceeding one-fifth of the price agreed upon for the whole course, provided, however, that in no case shall the total amount paid exceed the total price agreed upon for such course." (Section 61 of the Act)
- d/ "If there has been no lesson actually received, the institution may require only an indemnity not exceeding one-tenth of the total price agreed upon for such course." (Section 62 of the Act)
- e/ For the pupil's protection under sections 59, 61, and 62 of the Act and section 31 of the Regulations, as quoted above, the institutions undertakes not to transfer, assign or sell this contract.
